5.	<b>MINUTES OF THE LAST MEETING / MATTERS ARISING</b>	
5.2	<u>Matters Arising</u> No matters arising.	
5.2	<u>Minutes Of The Last Meeting</u> There was a technical error which meant the meeting could not be recorded as the clerk was unable to attend.	
6.	<b>HEADTEACHERS REPORT</b>	
6.1	The Headteacher has been absent from work with sickness and so this has not been drafted ahead of the meeting. Governors will receive a copy of the Headteachers report by the end of the week and any questions or challenge are to be sent in written form to the clerk.	
7.	<b>ATTENDANCE</b>	
7.1	Governors agreed at the last meeting that absence requests would be reviewed by the governing board to see if they meet the exceptional circumstances criteria.	
7.2	Governors review five requests that have been received from families to remove children from school during term time. Governors review the circumstances of each case and three absence requests are authorised and two are unauthorised.	
7.3	Parents may be asked to provide evidence of trips.	
7.4	It is agreed in the future governors will receive written requests in advance that are anonymised along with information about whether the child/children have SEN or are eligible for Pupil Premium, along with their attendance to date.	
7.5	Parents will be asked to give full and detailed reasons for the absence so that governors can scrutinise fully if it meets any of the agreed exemptions for absence.
